## Recovery & Recycling Program

### HOW IT WORKS

Why landfill something as trash when it can be made back into something that is healthy for the soil. The Greater Lebanon Refuse Authority is responsible for managing the Lebanon County's Municipal solid waste management practices. Diverting clean wood from the landfill is the first step in the recovery process.

Completion of the loop requires that the clean wood be processed and then put back out on the market for future use. GLRA's Clean Wood Recovery Program is a perfect example of completing the recycling loop. We take clean wood out of the waste stream and put it through a natural decomposition process which results in a high nutrient material. This final product is remarketed as mulch, thus the recycling loop is closed.

### OUR FEES & RATES (LEBANON COUNTY ONLY)

Container Rental (30 cubic yard container) **NO CHARGE\***

Recycling Fee (Per Ton-1 Ton Minimum) **\$36 Per Ton**

Container Drop-Off/Pick-Up Fee **\$135-\$175**

\*Fees & Rates based on one pick-up per 30 days

- Clean UNTREATED Wood
- Wood Pallets  
(Untreated, No Paint, No Preservatives, No Stains)
- Raw Lumber/Raw Lumber Scraps
- **NO Particleboard and NO Plywood**  
(These have glue & preservatives)
